Scope of Agreement

- 11. This discount may not be used in conjunction with any other Budget Energy Ltd electricity offer, discount or tariff, unless otherwise specified by Budget Energy Ltd during your registration and/or on your CAF.

Ending This Agreement

You may cancel the Tariff during the 10 working days from when the Agreement is first made ("Cooling Off Period") by calling us on Freephone 0800 012 11 77, by e-mail to customerservice@budgetenergy.co.uk or by writing to us by post to '30-32 Balliniska Road, Derry/Londonderry, BT48 0LY'. If you leave the Tariff after the "Cooling Off Period" or the Agreement is ended by you at any time before the end of the fixed term, a termination charge of £40.00 may be applied to your account.

Variations to this Agreement

- 15. Budget Energy Ltd reserves the right to amend the electricity unit rates or charges that apply to the Tariff at any time during the term if there is a cost imposed upon Budget Energy Ltd by a governmental or statutory body (including a change in VAT) or as otherwise provided for in the Budget Energy General Terms & Conditions. We will set these items out in your annual statement so that you know what charges have been required to be passed through to you.
- 16. Budget Energy Ltd reserves the right to withdraw the Tariff without notice at any time. If the tariff is removed existing 'Budget Bonus Summer Sizzler' customers will remain on the tariff until the end of their contract term. If your terms and conditions change during the term we will notify you 21 calendar in advance using your chosen method of communication

At the end of the Agreement

17. We will give you notice, between 21 and 42 calendar days in advance of the end of the Term of the Agreement coming to an end, using your chosen method of communication. We will notify you of the Standard 24 hr Keypad Tariff applicable at that time.
